Anna Herrhausen completed her Bachelor degree in Philosophy, Politics and Economics at the University of Oxford, her Masters in International Affairs at Columbia University, and obtained her doctorate at the Free University of Berlin. She lives with her family in Berlin.

**Daniela Kaiser** began her professional career at Deutsche Bank in 1999 and since then has worked in various divisions of the Bank at home and abroad. Her tasks focus on strategic project work, budget and cost management, as well as personal and organisational development. Daniela Kaiser is a certified banker, has a degree in economics and is a qualified foundation manager (European Business School).
